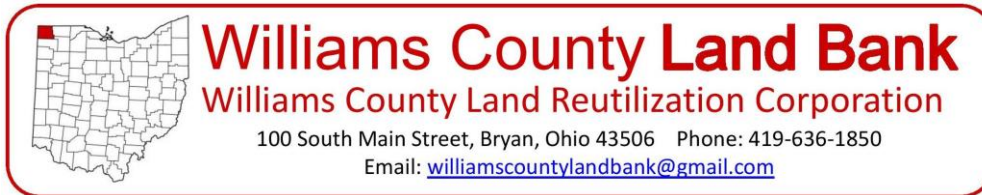

## SEALED AUCTION RULES

1. Bids will be accepted no later than 4:00 p.m. on Friday, July 26, 2019 to the Williams County Treasurer, 1 Courthouse Square #H Bryan, OH 43506. Bids must be labeled "Attention: Sealed Bid – 204 S. East Avenue Montpelier, OH." Bids emailed or otherwise electronically submitted cannot be accepted and will be rejected.
2. Bidders must be 18 years of age or older.
3. Minimum bid is \$3,000.00.
4. Bidders must write name, telephone number, street address, e-mail address, bid amount, and a brief description of the intended property use on the Sealed Bid Agreement form. Illegible bids will be disqualified.
5. Bidders must be current on all real estate taxes and assessments for any owned property in the County and cannot have had a tax foreclosure after January 1, 2010. Bidders must complete the Purchaser Qualification section within the Sealed Bid Agreement.
6. Bids cannot be made after the auction has ended.
7. Winner of the auction will be decided by the Williams County Land Reutilization Corporation Board with consideration first for the best use of the lot, and secondly, the highest responsive bid.
8. Bids will be opened at the Williams County Treasurer's Office, 1 Courthouse Square #H Bryan, OH 43506 at 11:00 a.m. on Monday, July 29, 2019. Bidders are not required to be present at the bid opening. Successful bidders will be notified via telephone, email, or mail.
9. The winning bidder must pay for the property from Tuesday, July 30, 2019 to Tuesday, August 6, 2019 from 8:00 a.m. to 4:00 p.m. at the Williams County Treasurer's Office, located at 1 Courthouse Square #H Bryan, OH 43506 (419-636-1850).
10. Payment must be made in full. Acceptable forms of payment include cash, check, or money order made payable to the Williams County Land Reutilization Corporation.
11. The winning bidder must sign an acknowledgment of receipt and disclaimer at time of payment. The Bidder will be responsible for any and all Closing costs as well as applicable taxes and assessments once the bid is awarded.
